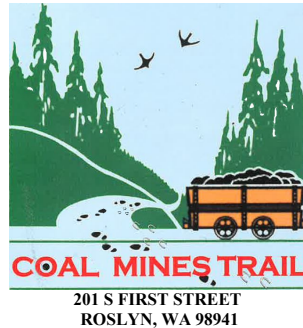

RE: Coal Mines Trail Interpretive Signage project – T-Mobile Hometown Grant Application

I'm writing in support of the ***Coal Mines Trail Interpretive Signage project***. The Coal Mines Trail was formed in 1994 as a co-operative effort among Kittitas County, the City of Cle Elum, and the City of Roslyn. The trail follows the Burlington Northern Railroad spur constructed in 1886 for the local coal mining industry and abandoned after the mines closed in 1963. The trail links the communities of Cle Elum, Roslyn, and Ronald.

The rail line is predated by a trail documented by local Indigenous peoples as a passageway toward Lake Cle Elum. This site is also significant to the culturally diverse communities that came to Roslyn, Ronald, and Cle Elum throughout the 20th century, including the 300 Black Americans who traveled to Roslyn to work in the coal field.

Existing trail signage from the 1990s has rotted away and leaves many stories untold. These signs simply label extant features, without telling a story. For example, one sign is labeled "mule barn" but does not explain the significance of mules and other animals used in the mining industry.

Updating the signage is a collaborative effort between the Mountains to Sound Greenway Trust, Roslyn Cle Elum School District, Roslyn Historical Museum Society, Roslyn Ronald Cle Elum Heritage Club, and the Coal Mines Trail Commission (CMT). The CMT Commission is an interlocal committee comprised of an elected representative and a citizen representative from each of the three trail stakeholders: Kittitas County, Cle Elum, and Roslyn.

This project will compliment various other efforts throughout the County to better preserve and maintain our historic areas of significance for future generations. Enhancing this signage creates opportunity for our small rural communities to connect to each other and a deeper sense of place.

The Coal Mines Trail Commission is pleased to support the ***Coal Mines Trail Interpretive Signage project*** and supports the installation of this project on our property. Please feel free to contact me if you have any questions.
