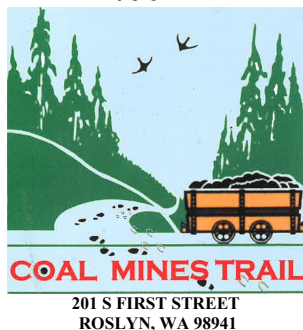

Spur Road off Shaft Street: Discussion on erosion control measures on the C.E. side of the CMT.

9. New Business

- a. Discussion on procedure for releasing Interpretive Sign pledge funds in the amount of \$15,000.00 to Mountains to Sound Greenway.

Funding Request:

The committee discussed seeking approval from the municipalities to increase the pledged amount for interpretive signage from \$1,100 to \$15,000. This approval is necessary to release funds from CMT to the Mountains to Sound Greenway Trust. Nolan will contact the City of Roslyn. Audrey will contact the City of Cle Elum. Laura will reach out to the County Commissioners. Motion: Greg (1st), Laura (2nd). Motion approved unanimously.

Drinking Fountain Installation:

Awaiting a timeline from Matt Bailey (City of Cle Elum Public Works). Goal: installation before Memorial Day weekend.

Howard Carlin Park (H.C. Park):

Laura and Nolan will develop low-cost landscaping ideas. Possible collaboration with the Boy Scouts or Mountains to Sound Greenway for native, low-maintenance plantings. Note: Determine if the City of Cle Elum has a small works roster for potential local landscaping contractors.

Upcoming Site Visit:

Next meeting: May 4, 2028, starting at Roslyn City Hall. Following agenda discussion, the committee will conduct a field visit to walk the trail to Ronald to identify sign locations and maintenance needs.

Trail Safety Signage:

Need to install warning signs and stop signs before the Highway 903 crossing. Similar signage should be added at Alliance Road and on the CMT.
